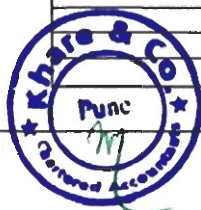

Review Report to

We have reviewed the accompanying statement of Unaudited Financial Results of **Pudumjee Industries Limited (the Company)**, Thergaon, Pune 411 033 for the quarter and six months ended 30th September, 2016 ("the Statement"). This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410. Review of Interim Financial Information Performed by the Independent Auditor of the Entity issued by the Institute of Chartered Accountants of India.
